BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, that the Commissioner of Transportation is hereby authorized and directed to erect and/or amend Traffic Warning Signs and Signals, for the following locations are hereby designated:

WARD TRAFFIC WARNING SIGNS AND/OR SIGNALS:

Ι	North Paulina Street, from West Division Street to North Milwaukee Avenue No Trucks over 5 tons-23-00424898 [02023-931]
II	West 37th Place (North & South Sides) From South Iron Street to South Loomis Place No Truck Parking All Times, All Days, -23-00427437 [Or2023-37]
12	South Sacramento Avenue from South Archer Avenue and West 47th Street; Single Direction Southerly by striking Southerly and inserting Northerly in lieu thereof [02023- 1661]
12	Amend Single Direction; North 47th Street to first alley from South Richmond Street to South Francisco Avenue (westerly) by striking westerly and inserting easterly in lieu thereof [02023-1662]
23	Amend Ordinance which reads: South Kedzie Avenue from 54th Street to West 55th Street; Two Way, Northerly and Southerly by striking Two Way and Southerly and inserting One Way, Northerly in lieu thereof; Single Direction [02023-1144]
24	South Tripp Avenue and West 14th Street; All Way Stop Sign, Stopping All Approaches [02023-1666]
