### ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. Chicago Department of Transportation, the Commissioner or his assignee, is hereby authorized and directed to approve a proposed Pullman Park-Phase 1 Subdivision being a Subdivision of part of the west half of Section 14, Township 37 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois for North Pullman 111<sup>th</sup>, Inc. (File No. 14-09-10-3214) in substantially the form shown in the attached drawing which, for greater certainty, is hereby made a part of this ordinance. Further, the Commissioner is authorized to approve the acceptance of the dedications shown on such drawing.

SECTION 2. The Subdivision herein provided for is made upon the express condition that within 365 days after the passage of this ordinance, North Pullman 111<sup>th</sup>, Inc shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with an attached drawing approved by the authorized staff of the Maps and Plats Unit of the Chicago Department of Transportation.
