Sign Ordinance

ORDINANCE

Be it ordained by the City Council of the City of Chicago:

Section 1. That the Commissioner[^] Buildings is hereby authorized and directed to issue a sign permit to Flashtic Incorporated, Division of Turk Electric Sign Company, 3434 North Cicero Avenue, Chicago, Illinois 60641, for the erection of a sign/signboard over 24 feet in height and / or over 100 square feet (in area of one face) at the 1133 North Dearborn LLC, 1133 North Dearborn Street. Chicago, Illinois 60610 with the dimensions, height and square foot area:

Dimensions: length: 12' height: &

Height above grade/ roof to the top of the sign: 30'

Total Square foot area: 96 square feet

Elevation: North
