That the Commissioner of the Department of Transportation, Ex Officio Examiner of Subdivisions, is hereby authorized and directed to approve a proposed closure to vehicular traffic of all of the south 121.13 feet of North Burling Street lying north of the north line of West Armitage Avenue in Block 26 in Canal Trustee's Subdivision of the north half of the southwest quarter and the east half of the southwest quarter of section (File Number 33-43-10-3213).
