BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Section 11-12-540 of the Municipal Code of

Chicago, the Commissioner of Water Management is hereby authorized and directed to cancel delinquent, existing and future water and sewer assessments, including fines and penalties, notwithstanding other ordinances of the City of Chicago to the contrary, assessed against Illinois Medical District facilities at said locations, as set forth on Exhibit A, attached hereto and made a part herof.
