To the President and Members of the City Council:

Your Committee on Traffic Control and Safety begs leave to recommend that Your Honorable Body Do Not Pass the sundry proposed ordinances and orders submitted herewith, which were referred to the committee (May 12, September 8, October 6, November 3, 10 and 17 and December 8, 2010) concerning traffic regulations and traffic signs, et cetera, as follows:

18 Two-Way Stop signs, Stopping east and westbound traffic on 73<sup>rd</sup> Street at Troy Avenue - Two-way stop was installed within the last year. There is insufficient data to evaluate the need for an all-way stop. 10-01768785 - POr2010-915;

26 Two-Way Stop signs, Stopping north and southbound traffic on N. Central Park Avenue at the intersection of W. Beach Avenue -Stop sign compliance has been shown to be very low on major streets when placed at intersections with minor one-way streets going away from the intersection. This will most likely create a safety hazard for pedestrians and for vehicles. 10-01558205 - POr2010-826;
