SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the current B2-3 Neighborhood Mixed Use District and M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 5-H in the following area:

West St. Paul Avenue; the alley next east of North Western Avenue; a line 70.50 feet south of West St. Paul Avenue; and North Western Avenue.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication February 2, 2011

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to amend the zoning from B2-3 Neighborhood Mixed-Use District and M1-2 Light Manufacturing/Business Park District to a B.V2 Community Shopping District for the area which is bounded by:

West St. Paul Avenue; the alley next east of North Western Avenue; a line 70.50 feet south of West St. Paul Avenue; and North Western Avenue.

(hereafter the "Property") will be filed on or about February 2, 2011 with the Department of Planning and Economic Development, City of Chicago by Center for Neighborhood

Technology, an Illinois not-for-profit corporation, 2125 W. North Avenue, Chicago, IL 60647 (hereinafter the "Applicant"). The addresses that correspond to the Property are

1737 - 41 N. Western Avenue. The Applicant is the owner of the Property.

The northern portion of the Property is currently improved with a two-story, approximately 9,000 sq. ft. building containing offices and commercial uses. To the south of the building is the balance of the Property, which is currently an grass area. The portion of the Property currently improved with the two-story building was previously rezoned to B2-3 to allow for conversion of the building, to residential units. That prior rezoning has expired. The portion which is currently an outdoor area is zoned M1-2. The Applicant has acquired the Property and wishes to retain the current improvements and continue the use of the Property for office uses. Accordingly, it is seeking to rezone the Property to clearly authorize the proposed uses under a single zoning district.

This notice is required by the Chicago Zoning Ordinance, Title 17, Section 13-0107-A of the Municipal Code of Chicago.
