BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

North Ashland Avenue; West Fry Street; the public alley that is next east of and parallel to North Ashland Avenue; a line that is 67.30 feet south of and parallel to West Fry Street, to those of a B2-3 Neighborhood Mixed-Use District.
