Permission and authority are hereby given and granted to HOT WOKS COOL SUSHI upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent, to its premises located at 2032 W. Roscoe St.. Said sidewalk cafe area #1 shall be fifty-seven (57) feet in length and twelve point five (12.5) feet in width for a total of seven hundred twelve point five (712.5) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N Seeley Ave. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:
