LOADING ZONES:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

WARD LOCATION

- 1 N. Damen Avenue (east side) from a point 20 feet north of W. Huron Street to a point 25 feet north thereof, 12:00 P.M. to 2:00 A.M., Tow Zone - 010-01365031 - PO2010-4803;
- 1 N. Bosworth Avenue (west side) from a point 60 feet north of W. Division Street to a point 40 feet north thereof, 9:00 A.M. to 2:00 A.M., Tow-Zone - 10-01548107 - PO2010-5367;
- 10 9233 S. Burley Avenue, At All Times - POr2010-816;
- 27 W. Fulton Street (south side) from a point 54 feet west of N. Fairfield Avenue to a point 73 feet west thereof, 5:00 A.M. to 6:00 P.M., Monday through Friday, Tow Zone - 10-01505074 -PO2010-5336;
- 27 W. Grand Avenue (south side) from a point 128 feet west of N. May Street to a point 17 feet west thereof, 8:00 A.M. to Midnight Tow-Zone - 10-02037009 - 02010-7175;
- 33 W. Irving Park Road (north side) from a point 78 feet east of N. Sacramento Avenue to a point 22 feet east thereof, 15 Minute Loading Zone use flashing lights, tow zone after 15 minutes 8:00 A.M. to 9:00 P.M. - 10-01781487 - PO2010-5869;
- 42 N. Rush Street (east side) from a point 50 feet north of E. Walton

Street to a point 35 feet north thereof, 7:00 A.M. to 5:00 A.M., Tow-Zone - 10-01903120 - 02010-5977;
