BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the current M3-3 Heavy

Industry District symbols and indications as shown on Map No. 5-H in the following area:

North Honore Street; North Elston Avenue; West Webster Avenue; and the alley next west of North Elston Avenue

to those of a M2-3 Light Industry District which is hereby established in the area described above.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication

The undersigned, Rolando R. Acosta, being first duly sworn on oath, deposes and say the following:

That the undersigned certifies that he has complied with the requirements of the Chicago Zoning Ordinance, Title 17, Section 13-0107-A of the Municipal Code of Chicago, by serving written notice by USPS first class mail, to the owners of all property within 250 feet in each direction of the lot lines of the subject property, the boundaries of which are:

North Honore Street; North Elston Avenue; West Webster Avenue; and the alley next west of North Elston Avenue

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to amend the zoning from an M3-3 Heavy Industry District to an M2-3 Light Industry District for the area which is bounded by:

North Honore Street; North Elston Avenue; West Webster Avenue; and the alley next west of North Elston Avenue

(hereafter the "Property") will be filed on or about March 2, 2011 with the Department of Housing and Economic Development, City of Chicago by 2230 Elston, LLC, 2222 N. Elston Avenue, Chicago, IL 60614 (hereinafter the "Applicant"). The addresses of the Property are 2215 - 25 N. Honore St., 2206 - 44 N. Elston Ave. and 1800 - 12 W. Webster Ave. The Applicant is the owner of the Property.

The Property is currently improved with multiple adjoining buildings of one and two stories in height. If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded or void), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City. Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

D. It is the City's policy to make this document available to the public on its Internet site and/or upon request. Some or all of the information provided on this EDS and any attachments to this EDS may be made available to the public on the Internet, in response to a Freedom of Information Act request, or otherwise. E. The information provided in this EDS must be kept current. In the event of changes, the Disclosing Party must supplement this EDS up to the time the City takes action on the Matter. contract requires. The Disclosing Party represents and warrants that:

F. 1. The Disclosing Party is not delinquent in the payment of any tax administered by the Illinois Department of Revenue, nor are the Disclosing Party or its Affiliated Entities delinquent in paying any fine, fee, tax or other charge owed to the City. This includes, but is not limited to, all water charges, sewer charges, license fees, parking tickets, property taxes or sales taxes. .

F.2 If the Disclosing Party is the Applicant, the Disclosing Party and its Affiliated Entities will not use, nor permit their subcontractors to use, any facility listed by the U.S. E.P.A. on the federal Excluded Parties List System ("EPLS") maintained by the U. S. General Services Administration.

F.3 If the Disclosing Party is the Applicant, the Disclosing Party will obtain from any contractors/subcontractors hired or to be hired in connection with the Matter certifications equal in form and substance to those in F.1. and F.2. above and will not, without the prior written consent of the City, use any such contractor/subcontractor that does not provide such certifications or that the Disclosing Party has reason to believe has not provided or cannot provide truthful certifications.
