- Disability must be permanent as evidenced by a copy of your valid driver's license, state identification placard and/or current vehicle registration submitted at the time of application;
- Proof of residency, in the form of a copy of your driver's license, state identification, or utility bills are submitted at the time of application.

Chicago, IL 60680-3100, ATTN: City of Chicago Permitting Section A \$25.00 maintenance fee will be billed to you annually.
