- Proof of residency, in the form of a copy of your drivers license, state identification, or utility bills are submitted at the time of application.

Box 803100, Chicago, IL 60680-3100, ATTN: Disabled Permitting Section. A \$25.00 maintenance fee will be billed to you annually.
