ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 18-E in the area bounded by

A line 200 feet south of and parallel to East 76th Street; the public alley next east of and parallel to South State Street; a line 199.5 feet north of and parallel to East 77th Street; South State Street, to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.

PROJECT NARRATIVE

A. The proposed zoning amendment from M1-2, Limited Manufacturing/Business District to B3-3, Community shopping District at 7627-43 South State Street is to allow for the construction of a new 4 story building to be used as a 3-star family oriented hotel with 81 rooms, meeting room, small fitness center for guests and office for employee with 43 parking stalls. There will be six lodging rooms, fitness center, lobby, office and meeting room on the first floor. The 2nd, 3rd and 4th floors will contain 25 lodging rooms each.

B. The proposed Floor Area Ratio is 1.1 less than the maximum of 3.0 allowed for B3-3 zoning district.
