BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Repeal ordinance passed heretofore which reads, West Ontario Street (north side) from a point 487 feet west of North Sedgwick Street, to a point 38 feet west thereof-loading zone - 5:00 P.M. to 12:00 P.M. -all days (06-00444889).

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

*Amendment Of Loading Zones.*

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Amend ordinance passed November 30, 2005 (Journal of the Proceedings of the City Council of the City of Chicago, page 62500) which reads:

"East 83<sup>rd</sup> Street (north side) from a point 60 feet west of South Cottage Grove Avenue, to a point 38 feet west thereof - 15 minute loading zone - 9:00 A.M. to 7:00 P.M. - Monday through Saturday"

by striking:

"15 minute loading zone"
