ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City is the owner of the vacant parcel of property comprising approximately 9,000 square feet located at 3611 N. jHalsted Street, Chicago, Illinois, (subject to final legal description, the "Property"); and

WHEREAS, the Property is adjacent to an improved property owned by Phoenix Electric Manufacturing Company (the "Developer") located at 3625 H. Halsted Street, Chicago, Illinois; and WHEREAS, the Developer has offered to purchase the Property from the City for Six Hundred Forty-Eight Thousand and no/100 Dollars (\$648,000) (the "Purchase Price"), which represents an amount that is eighty percent (80%) of its appraised fair market value of Eight Hundred Ten Thousand and No/100 Dollars (\$810,000.00), for use as a parking lot or for possible expansion to its existing improvements; and

WHEREAS, as consideration for the write-down of such purchase price, the Developer has agreed to certain covenants concerning the Developer's continued operation, the continued employment of existing employees and possible hiring of additional employees, and restrictions concerning the sale or lease of the Property (collectively, the "Use, Job and Resale Covenants"); and

WHEREAS, subject to approval by the Chicago Plan Commission and the publication of requisite notice advertising the City's intent to enter into a negotiated sale of the Property with the Developer, and the determination that there are no alternative responsive proposals, the City desires to convey the Property to the Developer for the Purchase Price; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council hereby approves the sale of the Property to the Developer for the Purchase Price.

SECTION 2. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Property to the Developer. In connection with the conveyance, the Developer shall also execute a purchase and sale agreement, in form and substance satisfactory to the Commissioner (the "Commissioner") of the Department of Housing and Economic Development (the

"Department") and to the Corporation Counsel. Such purchase and sale agreement or, in the alternative, deed restrictions in the City's quitclaim deed, shall include the Use, Job and Resale Covenants, as more particularly described on Exhibit A to this ordinance as covenants running with the Property, and shall include such other terms and conditions as the Commissioner of the Department and the Corporation Counsel shall deem necessary or appropriate.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any

reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders inconsistent with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall take effect upon its passage and approval.

Exhibit A

Use, Job and Resale Covenants

For a period of ten (10) years from the City's conveyance of the Property to the Developer, the Developer shall at all times comply with the following covenants:

1. Developer shall use the Property for its current manufacturing operations, and such additional manufacturing operations as may be permitted under applicable zoning law; '
2. Developer shall employ not less than thirty (30) full-time equivalent employees;
3. Developer shall not sell, lease or otherwise transfer its ownership of, or any interest in the Property, except in connection with a transfer of Developer's property at 3625 N. Halsted Street to a company that succeeds to the Developer's business operations and agrees in writing to be bound by the covenants specified in this Exhibit A;
4. Developer shall reinvest any financing proceeds attributable to a mortgaging of the Property in Developer's business operations and shall not distribute any such financing proceeds to investors or otherwise make cash distributions or payments that are not in the ordinary course of business from such financing proceeds.
5. In addition to the uses described under item #1 above, and subject to the Developer complying with any applicable laws and regulations and obtaining any required licenses or permits, the Developer will make the Property available for parking (paid or free) for special events or to serve the needs of neighboring businesses or for special events that serve the needs of the community, provided that such parking or other use does not interfere with (i) the normal and customary business operations of Developer or (ii) any plans to expand Developer's business operations.
6. Within twelve (12) months of the City's conveyance of the Property to the Developer, the Developer shall improve the appearance of the Property by removing the steel guard rails, installing a decorative metal fence, and providing landscaping along the Halsted Street frontage

The Developer's breach of any one or more of the above, which is not cured after any applicable notice and cure period, shall entitle the City to recover damages in the amount equal to the sum of (a) One Hundred and Sixty-Two Thousand and No/100 Dollars (\$162,000), such amount being an amount equal to the difference between the fair market value of Eight

Hundred Ten Thousand and No/100 Dollars (\$810,000) and the Purchase Price of Six Hundred Forty-Eight Thousand and No/100 Dollars (\$648,000), plus (b) simple, non-compounding interest on such sum at the amount of six percent (6%) per annum. The purchase and sale agreement, and/or deed restrictions imposed pursuant thereto, shall grant a first lien against the Property securing the conditional payment of such amount. Notwithstanding the foregoing, if the Developer obtains financing for the acquisition of the Property, the City shall execute a limited subordination agreement in form and substance reasonably acceptable to the Department and the Corporation Counsel, subordinating such lien to first mortgage lien granted to the lender providing such acquisition financing, up to an amount not greater than the lesser of (a) the amount of such acquisition financing, and (b) the Purchase Price (i.e., the lender providing acquisition financing for the Property shall have a first mortgage lien securing up to a maximum principal amount, not taking into account protective advances, equal to Six Hundred Forty-Eight Thousand and No/100 Dollars (\$648,000), assuming that acquisition financing in such amount is provided).
