### AMEND RESIDENTIAL PERMIT PARKING ZONES: BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Extend residential permit parking zone 163, 4:00 P.M. to 12:00 A.M. Monday through Sunday, by adding the 5600 block of N. Washtenaw Avenue (east side) Or2011-58 (Ward 40);  
Amend residential permit parking zone 119 on W. Scott Street (200 and 300 blocks) between N. Wells Street and the El tracks (both sides) by striking: (200 and 300 blocks) and (both sides) and inserting (south side) 225 through 309 and (north side) 210 through 310 (Ward 43);  
Amend residential permit parking zone/buffer zone 144 by striking: zone 144 and inserting: zone 1268 for the 4600 block of N. Sheridan Road, W. Lawrence Avenue between N. Winthrop Avenue and N. Sheridan Road, 4800 block of N. Kenmore Avenue - 02010-6785 (Ward 46);  
Repeal residential permit parking on the 4800 block of N. Hamilton Avenue - O2011-2098 (Ward 47);  
Extend residential permit parking zone 1394, 9:00 A.M. to 11:00 A.M., Monday through Friday, to include the 4600 and 4800 blocks of N. Hermitage Avenue (both sides) - Or2011-296 (Ward 47);  
Amend residential permit parking zone 1394, At All Times, All Days on the 4700 block of N. Hermitage Avenue (both sides) by striking: At All Times, All Days and inserting: 9:00 A.M. to 11:00 A.M., Monday through Friday -- O2011-2095 (Ward 47);  
Extend residential permit parking zone 1394, 9:00 A.M. to 11:00 A.M., Monday through Friday, to include the 4600 and 4800 blocks of N. Paulina Street (both sides) - O2011-2105 (Ward 47);  
Amend residential permit parking zone 1394, At All Times, All Days on the 4700 block of N. Paulina Street (both sides) by striking: At All Times, All Days and inserting: 9:00 A.M. to 11:00 A.M., Monday through Friday - O2011-2102 (Ward 47);
