### MEMORIAL RESOLUTION HONORING LORETTA W, CHLOPEK

WHEREAS, It is with great sadness that the City Council of the City of Chicago has been informed of the death of Loretta W. Chlopek; and

WHEREAS, God in His infinite wisdom had chosen to call His precious daughter, Loretta W. Chlopek home to her eternal reward at the age of eighty-four, Tuesday, May 5, 2009; and

WHEREAS, Born December 11, 1924, Loretta Willamennia was the loving daughter of Charles and Hannah Puis. She was the caring sister of fifteen siblings. During her lifetime, Loretta was affectionately known as "Willie", and "Lori" by her family and friends; after the birth of her grandchildren she was called "Nonnie"; and her second husband nicknamed her "Blondie"; and

WHEREAS, Loretta matured into a young woman filled with an abundance of grace, charm and wisdom and soon captured the heart of the man who was to become her husband, Samuel J.
