Be It Ordained by the City Council ofthe City of Chicago:

Permission and authority are hereby given and granted to TOCCO RESTAURANT upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 1266 N. Milwaukee Ave.. Said sidewalk cafe area #1 shall be eighty (80) feet in length and sixteen (16) feet in width for a total of one thousand two hundred eighty, (1280) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along Mauntene Court adjacent to Milwaukee. Ave. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday through Saturday 10:00 a.m. until 12:00 Midnight Compensation: \$1,408.00 SEATING CAPACITY: 80 Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1096508 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 though 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.
