TRIBUTE TO HORACE CLEVELAND BROY SR.

He has been recognized as well as received numerous recommendations and awards from citywide officials. One of his awards was the Best Neighborhood and Home Gardening.

WHEREAS, Horace Cleveland Broy is survived by his loving children: Horace Broy Jr., Theresa, Brenda, Herman, Denise, Judith, Pamela, Crystal, and Anna Bell, 12 grandchildren; 22 great grandchildren, 4 nieces, 1 nephew, numerous great nephews and nieces as well as a host of relatives and friends.
