BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single-Unit (Detached House) District symbols as shown on Map No. 16-D in the area bounded by:

A line 162.50 feet North of and parallel to East Marquette Road; a public alley next East of and parallel to South Woodlawn Avenue; a line 137.50 feet North of and parallel to East Marquette Road; South Woodlawn Avenue.

To those of an RM5, Residential Multi-Unit District
