### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-3 Light Industry District symbols and indications as shown on Map No. 8-G in the area bounded by

A line 796.01 feet north of and parallel to West 35<sup>th</sup> Street (as measured along the west boundary line of South Racine Avenue); South Racine Avenue; West 35<sup>th</sup> Street; the east boundary line of the south fork of the south branch of the Chicago River; the northeast boundary line of the south fork of the south branch of the Chicago River; a line 497.34 feet north of and parallel to the north boundary line of West 35<sup>th</sup> Street (as measured along the west boundary line of South Racine Avenue). NOTE: The right of way of the Chicago River and Indiana Railroad parcel is not included.

to those of a C2-3 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about May 12, 2011, I, the undersigned, will file an application for a change in zoning from a M2-3 Light Industry District to a C2-3 Motor Vehicle-Related Commercial District on behalf of South Branch LLC, owner of the property located at 1200 W. 35<sup>th</sup> Street.

The applicant seeks a zoning amendment to a C2-3 Motor Vehicle-Related Commercial District to allow a Type 1 zoning reclassification in order to allow residential and artists' live/work dwelling units above the first floor.

The applicant intends to use the subject property to allow an existing 5-story building of approximately 515, 505 sq. feet, with a proposed build-out area of 97,896 square feet, to build out 108 residential and artists' live/work units in a portion of the building on floors 2-5. No change will be made to the other existing uses in the 5-story building: the first floor has commercial space for several businesses, consisting of office space and warehouse space and the upper floors 2-5 have predominantly storage spaces. Currently there are 402 parking spaces.

The applicant/property owner is: South Branch LLC, 333 N. Michigan Avenue, ste 1700 Chicago, Illinois 60601. Paul Levy and Anthony Augustine are its members.
