ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.
Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 6-H in the area bounded by:

West Coulter Street; a line 336 feet northeast of the East boundary line of South Hoyne Avenue (as measured along the south boundary line of West Coulter Street); the public alley next South of and parallel to West Coulter Street; a line 312 feet northeast of the East boundary line of South Hoyne Avenue (as measured along the south boundary line of West Coulter Street); To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2. This Ordinance takes effect after its passage and approval. Common address of property: 2035 West Coulter Street, Chicago IL.
