ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 18-F in the area bounded by

A perpendicular line to South Lowe Avenue 50 feet south of and parallel to West 77th Street; South Lowe Avenue; a perpendicular line to South Lowe Avenue 100 feet south of and parallel to West 77th Street; the public alley next east of and parallel to South Union Avenue, to those of an RM4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
