ORDINANCE Pie Cafe, LLC Acct. No. 294900 - 3 Permit No. 1096981

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to Pie Cafe, LLC upon the terms and subject to the conditions bf this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 4664 N. Manor Ave.. Said sidewalk cafe area #1 shall be seventeen point five (17.5) feet in length and eleven point three three (11.33) feet in width for a total of one hundred ninety-eight point two eight (198.28) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N. Manor. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday through Saturday 8:00am until 8:00pm Compensation: \$600.00 SEATING CAPACITY: 24 Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1096981 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900
