ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-2 Neighborhood Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a southwesterly perpendicular line to North Milwaukee Avenue 47.90 feet northwest of the northwest boundary line of North Wood Street (as measured along the southwest boundary line of North Milwaukee Avenue); the public alley next southwest of and parallel to North Milwaukee Avenue; a southwesterly perpendicular line to North Milwaukee Avenue 73.03 feet northwest of the northwest boundary line of North Wood Street (as measured along the southwest boundary line of North Milwaukee Avenue), to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 3, 2011, I, the undersigned, will file an application for a change in zoning from a B1-2 Neighborhood Shopping District to a B3-2 Community Shopping District on behalf of the Golin Family Trust, owner of the property located at 1366 North Milwaukee Avenue.

The applicant seeks a zoning amendment to a B3-2 Community Shopping District in order to allow a Tavern which will apply for a Zoning Special Use.

The applicant intends to use the subject property to allow an existing 1-story building of approximately 3000 square feet, currently vacant, to be built out for a Tavern with a Public Place of Amusement for arcade games. No other change will be made to the existing space or the building height. Currently there is no parking.
