LOADING ZONES:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

WARD LOCATION

1 N. Rockwell Street (east side) from a point 20 feet north of W.

Diversey Avenue to a point 60 feet north thereof, No Parking Loading Zone 10:00 A.M. to 2:00 P.M., Tow Zone -- 11-00140643 02011-559;

28 W. Madison Street (north side) from a point 325 feet west of N.

Kostner Avenue to a point 25 feet west thereof, No Parking Loading Zone At All Times - 11-00380414 - O2011-898:

31 4123 W. George to N. Kearsarge Avenue (south side) Loading Zone/Tow Zone (Public Benefit);

32 W. Wabansia (south side) from a point 25 feet east of N. Elston Avenue to a point 60 feet east thereof and also from a point 135 feet east of N.
