### **PARKING PROHIBITED DURING SPECIFIED HOURS:**

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Pursuant to Title 9, Chapter 64, Section 080, of the Municipal Code of Chicago, the operator of a vehicle shall not park such vehicle upon the following public way in the areas indicated during the hours specified:

### **WARD LOCATION**

23 S. Luna Avenue (east side) from Archer Avenue to the first alley north, 7:00 A.M. to 9:00 A.M., All Days - O2011-3692;

27 N. Hoyne Avenue (west side) from a point 30 feet south of W.

Carroll to a point 25 feet thereof, Reserved Parking Disabled, 8:00 A.M. to 6:00 P.M., Monday through Friday 11-00802656 -O2011-2091;

36 W. George Street (south side) from N. Harlem Avenue to the first alley east thereof, No Parking 10:00 P.M. to 7:00 A.M., All Days Tow Zone - 11-00381526-O2011-938;

47 Within the ground level city owned parking lot, bounded by N.

Western Avenue, W. Leland Avenue, N. Lincoln Avenue and the CTA Brown Line, No Parking by order of the City of Chicago every Thursday from June 16 through October 27, 2:00 P.M. to 8:15 P.M., for the City's Farmers Market Program - 11-00382000 -O2011-985;

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
