ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Residential Single-Unit (Detached House) - District symbols and indications as shown on Map No. 13-J in the area bounded by a line 243.95 feet north of and parallel to West Catalpa Avenue; the alley next east of and parallel to North Sawyer Avenue; a line 183.95 feet north of and parallel to West Catalpa Avenue; and North Sawyer Avenue, to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
