BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Repeal ordinance passed 10-1-1997 page #53259 which reads, North Dearborn Street (east side) from a point 30 feet north of West Chicago Avenue, to a point 70 feet north thereof - towaway zone (97-0942).

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.
