BE IT ORDAINED BY THE CITY COUNCIL OF CHICAGO:

SECTION 1. Pursuant to Section 10-20-430 of the Municipal Code of Chicago, the Commissioner of Transportation and the Director of Revenue are hereby authorized and directed to exempt Monkey's Tire Shop and Auto Glass / Martin Cruz of 2446-48 West 59th Street from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to parking facilities for premise address.

SECTION 2. This ordinance shall take effect and be in force from and after its passage 4 and publication.
