PERCHANCE BOUTIQUE, INC Acct. No. 320666 - 2 . Permit No. 1097487

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PERCHANCE BOUTIQUE, INC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use seven (7) Awning(s) projecting over the public right-of-way adjacent to its premises known as 11 E. Walton St..

One (1) at eleven (11) feet in length, and two point nine one (2.91) feet in width for a total of thirty-two point zero one (32.01) square feet.

Said Awning(s) at E. Walton measure(s):

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1097487 herein granted the sum of one

hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
