ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-J in the area bounded by

A line 175 feet east of and parallel to North Spaulding Avenue; West Wabansia Avenue; a line 150 feet east of and parallel to North Spaulding Avenue; the public alley next north of and parallel to West Wabansia Avenue, to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.
