### LOADING ZONE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

#### WARD LOADING ZONES

4 S. Ellis Ave (east side) from a point 20 feet south of E. 43<sup>rd</sup> St. to a point 25 feet south thereof; No Parking Loading Zone, 9:00 AM to 12:00 AM (Midnight), All Days -- 11-00342401 [O2011-784]  
14 3434 W. 51<sup>st</sup> St., No Parking School Bus Loading Zone; 7:00AM to 5:00PM, Monday through Friday [O2011-6324]  
25 S. Racine Ave w/s from a point 30 feet north of W. Flournoy St. to a point 20 feet north thereof: 15 Minute Loading Zone, Use Flashing Lights, Tow Zone after 15 Minutes, 10:00 AM to 12:00 AM (midnight) -- 11-00784323 [O2011-1533]  
27 N. Washtenaw Ave (west side) from a point 15 feet south of W. Chicago to a point 25 feet south thereof; No Parking Loading Zone, Monday through Saturday, 9:00 AM to 5:00 PM, Tow Zone -11-03230069 [O2011-5151]  
27 N. Clybourn Ave (south side) from a point 6 feet east of N. Larrabee Ave to a point 35 feet east thereof; No Parking Loading Zone, Monday through Saturday, 6:00 AM to 8:00 PM, Tow Zone-11 -01801863 [O2011 -2820]

Pulaski Road to a point 25 feet west thereof, by striking 23 feet, 77 feet, Friday and inserting: 20 feet, 85 feet, Saturday: No Parking Loading Zone 6 AM to 4 PM, Monday through Saturday, Tow Zone - 11 -02447197 [O2011 -4405]
