BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following

locations are hereby designated as loading zones for the distances specified, during the hours specified:

27	N. Carpenter (east side) from a point 126 feet south of W. Fulton Market St. to a point 35 feet south thereof: No Parking Loading Zone, All days, 7:00AM to 11:00PM - 11-003712411 [02011-6534]
27	N. Carpenter St. from a point 30 feet north of W. Randolph St. to a point 149 feet north thereof: No Parking Loading Zone, All days, All times -- 11-03712422 [02011-6533]
30	N. Kenton Ave (east side) from a point 70 feet north of W. Cornelia Ave. to a point 25 feet north thereof: 15 Minute Loading Zone, use flashing lights, Tow Zone after 15 Minutes --11-03698176 [02011-4472]

Maxwell St. to a point 25' north thereof; 15 Minute Loading Zone, Use flashing lights, Tow Zone after 15 Minutes, 11:00AM to Midnight, by striking: 15 Minute Loading Zone, Use flashing lights, Tow Zone after 15 Minutes, 11:00AM to Midnight and inserting in lieu thereof: Loading Zone, 8:00AM to 12:00AM, All Days [02011-8766]
