ORDINANCE AMENDMENT Acct. No. 250887 -1 Permit No. 1094310

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1:

The ordinance passed by the City Council of the City of Chicago for PITCHFORK FOOD & SALOON on 10/05/2011, and printed upon page 8967 of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words

"Said Flag Pole(s) at w. Irving park measure(s): Five (5) at seven (7) feet in length, and one (1) foot in width for a total of thirty-five (35) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1094310 herein granted the sum of three hundred seventy-five (\$375.00) per annum in advance"

and inserting in their place the words

"Said Flag Pole(s) at w. Irving park measure(s):

Two (2) at seven (7) feet in length, and one (1) foot in width for a total of fourteen (14) square feet. The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1094310 herein granted the sum of one hundred fifty (\$150.00) per annum in advance"

Section 2:

This ordinance Amendment shall be in effect upon its passage.
