ORDINANCE Cook County Acct. No. 247783 - 8 Permit No. 1102691

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Cook County, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Conduit(s) under the public right-of-way adjacent to its premises known as 1800 W. Polk St..

Said Conduit(s) at Polk & Wood measure(s):

One (1) at twelve (12) feet in length, and point three three (.33) feet in width for a total of three point nine six (3.96) square feet.

Said Conduit(s) at W. Polk measure(s):

One (1) at five hundred sixty-four (564) feet in length, and one point three three (1.33) foot in width for a total of seven hundred fifty point one two (750.12) square feet.

One (1) at three (3) feet in length, and two (2) feet in width for a total of six (6) square feet.

One (1) at seven (7) feet in length, and point one seven (.17) feet in width for a total of one point one nine (1.19) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1102691 herein granted the sum of three thousand five hundred sixteen (\$3,516.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
