ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Cl-2 Neighborhood Commercial District symbols and indications as shown on Map No. 2-1 in the area bounded by:

The alley next north of West Harrison Street; a line 324.83 feet east of South Francisco Avenue; West Harrison Street; and South Francisco Avenue

to those of a RMS Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
