ZONING NARRATIVE

Marillac Social Center 2847 W. Jackson Blvd. Chicago Illinois

This is a proposed zoning amendment to amend the RT-4 zoning district to the B3-3 zoning district in order to add the subject property to a larger development site with the zoning designation of B3-3:

- The subject property is located at 2847 West Jackson Blvd. and is bounded by West Jackson Blvd.; a line 143.56 feet East of and parallel to North Francisco Avenue; the alley next South of and parallel to West Jackson Blvd.; and a line 118.56 feet East of and parallel to North Francisco Avenue and contains approximately 3,126 square feet of property.
- 2. The subject property is currently vacant.
- 3. The site is bounded by zoning district RM-5 to the North, by RT-4 to the East, RT-4 to the South and B3-3 to the West.
- 4. The Applicant proposes to add the subject property to a larger development site in order to rehabilitate their existing 23,809 sq. ft. building located at 2849 W. Jackson Blvd., and to add on a 3,514 sq. ft. addition for a new community center containing a total of 27,323 sq. ft. The new community center will provide social service programing space for computer labs, classroom space, offices, library facilities as well as recreational areas consisting of a gymnasium, fitness area, stage, and recreation room and will maintain the existing food pantry.
- 5. Zoning Analysis:
 - a. FAR: permitted 3.0 FAR as proposed: 0.66
 - b. Number of dwelling units: zero
 - c. Setbacks: North 2', East 3'-I", South 0' and West 11"
 - d. Height: 26'-1'
 - e. Parking: If the proposed zoning change is approved for the subject property, the applicant will seeking special use permits to establish and to operate the new community center upon the larger development site located at 2847-59 W. Jackson Blvd. and 301-311 S. Francisco Avenue and a special use permit to allow required parking for the proposed community center to be provided off-site across the street from the proposed community center at a surface parking lot located at the southwest corner of Jackson Blvd. and Francisco containing 51 parking spaces. The required parking for a community center is determined by the Department of Housing and Economic Development.
