# **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 9-H in area bound by

North Wolcott Avenue, West Addison Avenue, a line 50.50 feet East of and parallel to North Wolcott Avenue, the alley next South and parallel to West Addison Avenue.

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
