Your Committee on Transportation and Public Way begs leave to report and recommend that Your Honorable Body pass An amendment to an ordinance passed by the City Council of the City of Chicago on January 17, 2013, and printed on page 45617 of the C.J.P. of the City of Chicago, is hereby amended by deleting the words, "Standardization of Chicago Avenue, at Wolcott Avenue, southeast corner, as John J.
