ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 5-J in the area bound by:

The public alley next south of and parallel to west Fullerton Avenue; north Hamlin Avenue; a line 31.90 feet south of and parallel to the public alley next south of and parallel to west Fullerton Avenue; the public alley next west of and parallel to North Hamlin Avenue.

to those of a RS-3 Residential Single -Unit (Detached House) District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
