COMMERCIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 413-415 S. Wells Street are owned by Chicago Title Land Trust Company, as Successor Trustee under trust agreement dated March 12, 1996 and known as TRUST NUMBER 1-2434; and

WHEREAS, the beneficiary of Chicago Title Land Trust Company, as Successor Trustee under trust agreement dated March 12, 1996 and known as TRUST NUMBER 1-2434, proposes to fence, secure and use the portion of the alley to be vacated herein for fire escape access, parking and drop off; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public alley, and opening of a portion of S. Financial Place as currently built and traveled; both as described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION

1.

An Opening of S. Financial Place for use as a Public Street in Section 16, Township 39 North, Range 14, East of the Third Principal Meridian, City of Chicago, Cook County, Illinois described as follows:

The East 23 feet of Lot 7 in Micajah Glascock's Subdivision and the North - South 12 foot wide public alley lying East of the East line of Lots 1 through 6 and, said 12 foot wide public alley extended 10 feet South of the South line of Lot 6 extended East; also the 10 foot wide East - West Alley lying South of said Lot 7, all in Micajah Glascock's Subdivision of part of Block 99 in School Section Addition to Chicago, according to the Plat thereof recorded September 19, 1866 as Document number 123151 (Ante-Fire), all in the City of Chicago, Cook County, Illinois, containing 5600 square feet, more or less, and as shaded and legally described by the words "HEREBY OPENED FOR PUBLIC STREET" on the Plat hereto attached as Exhibit A, which Plat for greater clarity, is hereby made a part of this ordinance.

A Vacation of the Public Alley in Section 16, Township 39 North, Range 14, East of the Third Principal Meridian, City of Chicago, Cook County, Illinois described as follows:

All of the East-West 10 foot wide public alley lying East of the East line of S. Wells Street, lying West of the West line of the North-South 12 foot public alley, to be opened

for a public street known as S. Financial Place; lying South of the South line of Lot 6 in Micajah Glascock's subdivision of part of Block 99 of School Section Addition to Chicago (ante-Fire) of Section 16, Township and Range aforesaid, and lying North of the North line of Lot 4 in Assessor's Division of Part of Block 99 of said School Section Addition to Chicago, according to the plat thereof recorded September 19, 1866 as Document Number 123151 (Ante-Fire), all in the City of Chicago, Cook County, Illinois, containing 1000 square feet, more or less, and as shaded and legally described by the words "HEREBY VACATED" on the Plat hereto attached as Exhibit B, which Plat for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The City of Chicago hereby reserves the area herein vacated, as a right of way for existing Water Department sewers and sewer structures, for the installation of any additional sewers, sewer structures and appurtenances now located or, which in the future, and be located in the alley as herein vacated, and for the maintenance, renewal and reconstruction of such facilities. It is also provided that, the City shall have 24 hour access to the area to be vacated; that no buildings or other permanent structures shall be erected on said right of way herein reserved, or other use made of said area, which in the sole discretion and judgment of the respective municipal officials having control of the aforesaid service facilities, would interfere with the use, maintenance, renewal, or reconstruction of said facilities, or the construction of additional municipally-owned service facilities; and that all sewers structures shall be exposed to grade. It is further provided that any vacation-beneficiary prompted adjustments to sewer facilities in the area to be vacated; and the repair, renewal or replacement of any private materials, or private property damaged in the area to be vacated as a result of the City exercising its easement rights shall be done at the beneficiary's expense.

SECTION 3. The City of Chicago hereby reserves the alley as herein vacated, as a right of way for the Department of Fleet and Facility Management (or successor Department) for facility maintenance, repair, renewal, reconstruction of any portions of the adjacent facility located at 417-419 S. Wells Street (including, but not limited to any and all above-grade ducts that protrude into the air space of the alley), with the right of ingress and egress at all times upon reasonable notice. It is further provided that no buildings or other structures shall be erected on the said right of way herein reserved or other use made of said area, which in the sole and exclusive judgment of the municipal officials having control of the aforesaid service facilities would interfere with the use, maintenance, repair, renewal, reconstruction, or disposition of said facility. It is also provided that the beneficiary of the alley vacation shall hold harmless and indemnify the City from any damages to private materials located in the area to be vacated, as a result of the City exercising its easement rights.

SECTION 4. The City of Chicago hereby reserves for the benefit of Commonwealth Edison its successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated

equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the alley herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of Commonwealth Edison's facilities. No buildings, permanent structures or obstructions shall be placed over Commonwealth Edison's facilities without written release of easement by Commonwealth Edison. Any future relocation of Commonwealth Edison's facilities lying within the area being vacated will be done by Commonwealth Edison

SECTION 5. The vacation herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, the beneficiary of Chicago Title Land Trust Company, as Successor Trustee under trust agreement dated March 12, 1996 and known as TRUST NUMBER 1-2434 shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the owner of the property abutting said part of public street hereby vacated the sum

), which sum in the judgment of this body will be equal to such benefits.

SECTION 6. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the applicant shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with an attached drawing approved by the Superintendent of Maps and Plats.

SECTION 7. This ordinance shall take effect and be in force from and after its passage. The vacation shall take effect and be in force from and after its recording. Gabe $K\$
