### **ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the M1-2, Limited Manufacturing/Business Park District symbols as shown on Map No. 5-H in the area bounded by:**

**A line 96.12 feet North of and parallel to West Wabansia Avenue; North Damen Avenue; a line 72.09 feet North of and parallel to West Wabansia Avenue; the public alley next West of and parallel to North Damen Avenue.**

**To those of a B3-2, Community Shopping District**
