ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM-5, Residential Multi-Unit District symbols as shown on Map No. 3-F in the area generally bounded by:

a line beginning at a point 114.07 feet north of West Goethe Street and extending east to a point 114.11 feet north of West Goethe Street; North Dearborn Parkway; West Goethe Street; and the alley next west of and parallel to North Dearborn Parkway

to those of a B3-5, Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.

In compliance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about May 8, 2013, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of 1300 Dearborn Property, LLC, the owner and Applicant, for the property commonly known as The Three Arts Club located at 1300 North Dearborn Parkway.

The Applicant, 1300 Dearborn Property, LLC, proposes to renovate and restore the Three Arts Club, a Chicago Landmark, for use as a furniture gallery and accessory restaurant. The application requests a change in zoning from RM-5, Residential Multi-Unit District, to a B3-5, Community Shopping District. The Three Arts Club is currently vacant and is a non-conforming building. The proposed zoning change will establish a zoning classification that conforms to the bulk of the existing building; allow for the proposed use; and allow for additional floor area.

1300 North Dearborn Parkway Type 1 Amendment Applicant: 1300 Dearborn Property, LLC

The existing building at 1300 North Dearborn Parkway, the Three Arts Club, is a designated Chicago Landmark, and it has been vacant for the last several years. The existing zoning classification is RM-5 and the proposed zoning classification is B3-5, thus the need for

a Type 1 rezoning.


The Three Arts Club occupies a site containing 17,055 square feet, and is a nonconforming building. The floor area of the existing building is approximately 57,887 square feet. The actual floor area ratio ("FAR") is 3.39, well above the permitted FAR of 2.0. The building is set back approximately 15' along Dearborn Parkway, but the remainder of the building is constructed lot line-to-lot line. The building has no on-site parking or loading. The existing building height is 69'.

The proposed use of the building is retail (furniture gallery) with an accessory restaurant. The proposed renovation to the building includes construction of a glass roof over the interior courtyard on the first floor (thereby increasing the floor area by 2,210 square feet); and construction of a roof addition to provide elevator access (thereby increasing the floor area by an additional 2,175 square feet). The additional floor area created by enclosing the courtyard and adding a roof top addition will increase the total floor area to 62,272 square feet with an FAR of 3.65. The addition to the roof will not increase the height of the building - it will remain at 69'. A new roof terrace will be constructed adding 7,931 square feet of open space. No onsite parking or loading is required because the building is a designated Chicago Landmark. A trash storage facility will be located inside of the building and located off the alley.

The attached drawings and plans depict the existing elevations; proposed additions; building height; and general building orientation.


