ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.3-G in the area bounded by

West Fry Street; a line 154.62 feet east of and parallel to North Ashland Avenue; the alley next south of and parallel to West Fry Street; and a line 129.56 feet east of and parallel to North Ashland Avenue,

to those of a RT4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The existing two-story single-family home will be razed. The proposed zoning amendment will allow the Applicant to redevelop the site with a new three-story (with basement), three (3) dwelling-unit, all residential building (approx. 5,004 sq. ft.). The proposed new building will contain one duplex unit (between the basement and 1st floor) and one simplex unit on, each, the 2nd and 3rd floors, respectively. The proposed new building will provide porches off the rear of each of the dwelling units (at the 1st, 2nd and 3rd floors), as well as a communal rooftop deck. There will also be a detached, three-car garage, with rooftop deck, at the rear of the lot. The proposed building will be constructed to a height of 44'-10".
