ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-1 Neighborhood Shopping District symbols and indications as shown on Map No. 10-D in the area bounded by

South Cottage Grove Avenue, the public alley next east of and parallel to South Cottage Grove Avenue, a line 198.3 feet South of and parallel to East 43rd street, a line 223.3 feet South of and parallel to East 43rd street.

To those of a B3-1 commercial shopping district.

Section 2. This ordinance takes effect after its passage and approval

Existing 2 story building with 2 commercial units that will be used as a banquet facility and public place of amusement that will be rented to the public for both public and private events, such as live entertainment, wedding receptions, birthday parties and other similar events. The first floor of the building is 3200 square feet, the second floor of the building is 3200 square feet.

There is no on-site parking, however owners plan to apply for an administrative adjustment that will allow for the use of a shared parking lot that is less than 100 feet away from the property with 28 parking spaces. Additionally, owners have acquired a vacant lot that is at the immediate rear of the property that will be developed to provide additional 30 parking spaces. The owners plan to submit a separate application for an administrative adjustment to address all parking.
