# SUBSTITUTE ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Chapter 7-24 of the Municipal Code of Chicago is hereby amended by adding the language underscored, as follows:

#### 7-24-099 Possession of cannabis.

(Omitted text is unaffected by this ordinance)

(f) This section shall not apply to possession of medical cannabis by a person in compliance with the Medical Cannabis Pilot Program Act, 410 ILCS 130/1 et seq.

#### 7-24-225 Unlawful drugs in motor vehicle - Impoundment.

(d) This section shall not apply to the owner bf a motor vehicle containing medical cannabis possessed in compliance with the Medical Cannabis Pilot Program Act, 410 ILCS 130/1 et seg.



#### 17-17-0200 General Terms.

17-17-0296 Marquee Sign. A sign incorporated into or attached to a marquee or permanent canopy.

17-17-0296.5 Medical Cannabis Cultivation Center. A facility operated by a person who is registered by the Illinois Department of Agriculture to perform necessary activities to provide only registered medical cannabis organizations with usable medical cannabis.

17-17-0296.7 Medical Cannabis Dispensing Organization. A facility operated by a person who is registered by the Illinois Department of Financial and Professional Regulation to acquire medical cannabis from a medical cannabis cultivation center for the purpose of dispensing cannabis,

paraphernalia, or related supplies and educational material to registered qualifying patients. For purposes of this definition, "Qualifying patient" has the meaning ascribed to that term in the Compassionate Use of Medical Cannabis Pilot Program Act, 410 ILCS 130/10.
