# **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Cl-1, Neighborhood Commercial District symbols as shown on Map No. 16-N in the area bounded by:

West 63<sup>rd</sup> Street; a line 158 feet east of and parallel to the center line of South Harlem Avenue or a perpendicular line 98 feet long that is 109.41 feet west of the northwest boundary line of the Belt Railroad right-of-way (as measured along the south boundary line of West 63<sup>rd</sup> Street); the northwest boundary line of the Belt Railroad right-of-way; a line 265.03 feet south of and parallel to West 63<sup>rd</sup> Street (as measured along the northwest boundary line of the Belt Railroad right-of-way ending at a point 114.01 feet east of the center line of South Harlem Avenue); the east boundary line of South Harlem Avenue.

To those of a C2-2, Motor Vehicle-Related Commercial District SECTION 2. This Ordinance takes effect after its passage and approval.
