SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the current Cl-2 Neighborhood Commercial District symbols and indications as shown on Map No. 6-G in the area bounded by:

the alley next north of West 27th Street; a line 30.00 ft. west of South Halsted Street; West 27th Street; and a line 80.00 feet west of South Halsted Street

to those of a RS-3 Residential Single-Unit (Detached House) District which is hereby established in the area described above.
